The Kass Kounty King Korn Klub is asking for the closing of the following streets for September 9,10,11,12, and 13, 2009.

The Blue's Amusements will be setting up their midway on Sept. 9th on 4th Street to 1st Ave. and will tear down Sept. 13th. The Midway will be using the City Parking Lot also during this time. The Midway will open Thursday afternoon.

Wednesday, September 9th--no activities planned by the Klub

Thursday, September 10th, the stage will be set up at 4th and Main. There will be no activities sponsored by the Klub downtown Thursday.

Friday, September 11th, we ask for the closing of the following streets:

- 1. 4th St. between Ave. A and Main from 11:30am.until midnight.
- 2. 5th St. from Ave. A to 1st Ave. from 7:30am. until midnight.
- 3. Main Street from 4th St. to 7th Street from 11:30am. until midnight. Main Street 4th to 3rd for unloading equipment, etc. Will not need to eliminate business parking.
- 4. Ave. A from 7th St. to 4th St. from 11:30am. until 4:00pm.
- 5. 6th St. from alley by Cass County Bank to 1st. Ave. from 11:30am. until 9:00pm. for Kiddie parade and activities following including: Talent show, Pep Rally, Lil Tuggers, and Korn Eating Contest and the Kar Show which lines up 5:00pm. The Antique Tractor show and race will be starting at 4:00pm. We will be having various activities during the afternoon on all of the closed streets.
- 6. We have planned a street dance on Main St. with different bands performing after the Kar Show.

PLEASE NOTE: CHANGE OF PARADE TIME--2:00pm.

Saturday, September 12, we are asking for the closing of the following streets:

- 1. 5th Street from Ave. A north to Ave. B for parking of visiting fire and rescue equipment from 8:30am. until after fire department's dinner.
- 2. 4th Street from Ave. A to Main St. from 8:30am. until after midnight. This is because of the change of the Parade time on Sat.
- 3. Main Street from 4th to 7th from 8:30am. until midnight. 3rd to 4th for Cow Chip Bingo before the parade and unloading of equipment. We have street activities starting at 10:00am. and continuing all day and evening.
- 4. Washington Ave. at 10th Street to Ave. A. from 11:30am. for parade line-up. It helps because 10th Street goes South to Chicago Ave. traffic will move smoother that way we feel. Ave. C will be alternative route to get to 3rd St. to reach Highway 34 Bridge. Judging of floats will be from 12:30pm.to 1:00pm. on Ave. A by Stuebe's.
- 5. Ave. A from 7th Street to 4th St. closed from 9:00am. until after parade about 3:30pm.
- 6. 6th St. from alley by Cass County Bank to 1st Ave. from 8:30am. to make it easier for

parade route to be free of parker vehicles.

7. We have planned activities on Main Street after the parade and another street dance in the evening until midnight.

For you information, Thursday, Sept. 10th, we are having the Past Royalty Dinner, Kornation, and Reception at St. John's School and will probably need some traffic control there. The Dinner starts at 5:00pm. and we should be ending the activity about 9:00pm. From 8:30pm. until 9:30pm. will be the heaviest use of 18th Street.

We really need to keep 4th Street closed for equipment loading and unloading for the groups who are coming both Friday and Saturday.

As noted, there is no parade Friday evening, but the Kar Show will have lots of traffic.

We have the Antique Machinery Show setting up in Les Wentz's lot Friday and being there all day Sat. They will be using Main for their Slow Tractor Pull Friday afternoon.

Sunday, Sept. 13th, the Garden Tractor and Tractor Pull will be east of Main Street by the railroad tracks again but will not need any special closings.

The Fire Dept has notified us that they will be hosting visiting departments for the parade on Sat. but no competition. We will make space for them.

Even though there is not Tent on 5th Street this year, we are planning using it for other activities such as more space for Food Court/ Flea Market and/or adding Kid friendly activities sponsored by local organizations Sept. 11 and 12.
