ITEM 7 A

Council Member Bowman introduced an ordinance numbered and titled as follows: ORDINANCE NO. 1782-AN ORDINANCE TO AMEND THE PLATTSMOUTH LAND DEVELOPMENT ORDINANCE FOR THE CITY OF PLATTSMOUTH BY CHANGING CERTAIN BOUNDARIES FROM AGRICULTURAL DISTRICT (AG) TO URBAN RESIDENTIAL LOW DENSITY DISTRICT (R1); TO REPEAL ALL ORDINANCES OF THE CITY IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE. Motion by Bowman, seconded by Jenkins that the statutory rule requiring reading an ordinance on three different days be suspended and that Ordinance No. 1782 be adopted on first reading by title only. ROLL CALL: Yes-Tilson, Wassinger, Jenkins, Tesarek, Derby, Porter, Kerns and Bowman. No-None. Absent-None. MOTION CARRIED. Said ordinance was read by title only and thereafter Jenkins moved for final passage of the ordinance, which motion was seconded by Tesarek. ROLL CALL: Yes-Wassinger, Jenkins, Tesarek, Derby, Porter, Kerns, Bowman and Tilson. No-None. Absent-None. Abstain-None. MOTION CARRIED. Said ordinance was read in to the record by title only.

ITEM 7 B

Motion by Bowman, seconded by Tilson to adopt Resolution No. 09-004:

RESOLUTION NO. 09-004

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLATTSMOUTH, CASS COUNTY, NEBRASKA TO ESTABLISH AN ADVISORY BOARD TO THE MAYOR AND CITY COUNCIL KNOWN AS THE PLATTSMOUTH EMERGENCY MEDICAL SERVICES BOARD, THE GENERAL PURPOSE OF WHICH IS TO STUDY AND MAKE RECOMMENDATIONS TO THE MAYOR AND CITY COUNCIL REGARDING THE TRANSITION OF THE FIRE DEPARTMENT, RESCUE SQUAD DIVISION, FROM A SOLELY VOLUNTEER DIVISION TO PAID OR COMBINATION OF VOLUNTEER AND PAID DIVISION.

WHEREAS, pursuant to Ordinance 8-101, the City shall provide for fire protection and emergency rescue squad service by and through the City Fire Department;

WHEREAS, pursuant to *Neb. Rev. Stat.* § 16-201 the City shall have the power to do all acts in relation to the concerns of the city necessary to the exercise of its corporate powers;

WHEREAS, the City, through an independent consultant, performed an Emergency Medical Services System Assessment and desires to proceed with implementing recommendations resulting from the assessment; and

WHEREAS, the Rescue Squad Division of the Fire Department desires to improve its response time to calls for service and its staffing system.

NOW THEREFORE, BE IT RESOLVED that the Mayor, with the consent and approval of the City Council, be authorized to appoint the a Plattsmouth Emergency Medical Services Board. (Board).

BE IT FURTHER RESOLVED that the Board shall consist of six volunteer citizens, that includes the expertise of a physician; banker or accountant; an executive director of a primarily volunteer non-profit organization; a citizen who is not now, nor has ever been, a member of the Rescue Squad Division of the Fire Department; and two elected official, one of whom is from the City and one of whom is from the county but within the district boundaries of the Plattsmouth Fire Department. Upon the initial appointment of the Board, two members shall serve for one year from appointment, two members shall serve for two years from appointment and two members shall serve for three years from appointment. Thereafter, members of the Board shall be appointed to serve a three-year term unless reappointed. Members shall serve without compensation. Vacancies occurring in the Board shall be filled by appointment for the unexpired term.

BE IT FURTHER RESOLVED that before entering upon his/her duties, each board member shall take an oath to be filed with the city clerk that he/she will faithfully perform the duties of his/her office and not in any manner be actuated or influenced therein by personal or political motivation.

BE IT FURTHER RESOLVED that at the time of the Board's first meeting, and at it first meeting in each February thereafter, the members shall organize by selecting from their number a Chair, Vice Chair and a secretary. It shall be the duty of the secretary, or the secretary's designee, to keep the full and correct minutes and records of all meetings and to file the same with the city clerk where they shall be available for public inspection at any reasonable time. A majority of the Board members shall constitute a quorum for the transaction of business. The Board shall adopt by-laws for the governance of the body. A majority of the Board shall constitute a quorum for the transaction of business and a majority vote of the total membership shall be required to pass any motion or resolution.

BE IT FURTHER RESOLVED that the Board shall have responsibility to investigate and study, and to present a plan to the Mayor and City Council for, the transition from a volunteer

rescue squad division to a paid and combination paid and volunteer division. Provided further that the Board shall seek to implement the recommendations of the Emergency Medical Services System Assessment dated July 16, 2008.

BE IT FURTHER RESOLVED that any member may be removed from office for any reason, but no member shall be removed from office by a vote of less than three-fourths of City Council as a whole.

WHEREAS, the City of Plattsmouth is subject to the April 11, 1994 Clean Water Act and Combined Sewer Overflow Policy of the Environmental Protection Agency;

WHEREAS, the City of Plattsmouth has a Combined Sewer Overflow permitted as Outfall 002 as part of the National Pollutant Discharge Elimination System through the Nebraska Department of Environmental Quality;

WHEREAS, the Mayor and City Council have committed to completing all phases of the Combined Sewer Overflow Separation Project by the end of 2015;

WHEREAS, the cost of complying with this presently unfunded federal mandate has been estimated by the City's consulting engineers to be \$7,137,000;

WHEREAS, the City Council supports a request for federal funds to assist Plattsmouth with Phase 1 of the Combined Sewer Overflow Separation Project;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Plattsmouth that the City supports submitting a request for federal funds to United States Senator E. Benjamin Nelson to assist Plattsmouth with Phase 1 of the Combined Sewer Overflow Separation Project and that Congress be asked to appropriate such funds.
