ITEM 9 D

Motion by Bowman, seconded by Wassinger to adopt a resolution numbered and titled:

RESOLUTION NO. 10-012

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, as follows:

- 1. The Mayor and Council hereby find and determine that notice requesting applications for ownership and operation of off-street parking facilities has been published as required by Section 19-3311, R.R.S. Neb. 2007; that no applications have been received by the City; and that the City is now authorized under the terms of such section to commence a program for the acquisition and construction of off-street parking facilities.
- 2. The Mayor and Council hereby find and determine that it is necessary and advisable for the City to encourage economic stability and growth, and that for such purposes it is necessary and advisable for the Mayor and Council to proceed under Sections 19-3301 to 19-3327, R.R.S. Neb. 2007, as amended, (the "Act").
- 3. The Mayor and Council hereby further find and determine that it is necessary and advisable for the City to commence a program to construct and improve off-street parking facilities within the City of Plattsmouth, Nebraska, and that for such purpose it is necessary and advisable that boundaries be established for an off-street parking district to be created pursuant to the Act and to be designated as Vehicle Off-Street Parking District No. 1 of the City of Plattsmouth, Nebraska.
- 4. The proposed boundaries of Vehicle Off-Street Parking District No. 1 of the City of Plattsmouth, Nebraska, shall be the same as the corporate boundaries of the City.

Said boundaries are hereby determined to include all those properties within the City of Plattsmouth which might be specially benefited by off-street parking improvements within said proposed district. The costs of off-street parking facilities to be acquired and constructed and the costs of operating and maintaining such facilities are expected to be paid for from general property taxes, with financing being provided by issuance of the City's general obligation bonds, all as provided for in the Act.

5. 7:00 o'clock P.M. on the 3rd day of May, 2010, at City Hall, 136 North 5th Street, Plattsmouth, Nebraska, is hereby set as the time and place of a hearing before the Mayor and Council on the creation of said district. At said hearing, any protest or objections to the creation of said district as contemplated in this resolution shall be received, heard and considered. The City Clerk is hereby instructed to give notice of such hearing by publication one time each week for not less than three weeks in the Plattsmouth Journal, a weekly newspaper of general circulation published in the City of Plattsmouth. Such notice to be published pursuant to this resolution shall be in the following form:

NOTICE OF INTENTION TO CREATE VEHICLE OFF-STREET PARKING DISTRICT NO. 1 OF THE CITY OF PLATTSMOUTH, NEBRASKA

Public Notice is hereby given that the Mayor and Council of the City of Plattsmouth, Nebraska, have determined that it is advisable and necessary to commence a program to construct and acquire off-street parking facilities within the City of Plattsmouth pursuant to the provisions of Sections 19-3301 to 19-3327, R.R.S. Neb 2007, as amended, and have by resolution proposed the creation of Vehicle Off-Street Parking District No. 1 of the City of Plattsmouth, Nebraska. The proposed boundaries for said district are the same as the corporate boundaries of the City.

Notice is further given that a public hearing will be held at 7:00 o'clock P.M. on May 3, 2010, at City Hall, 136 North 5th Street, Plattsmouth, Nebraska, before the Mayor and Council on the creation of said district. Not later than such hour for said hearing, the owners or any persons interested in any real estate within said proposed district may severally or with other owners file with the City Clerk written objections to the creation of said district and to said program, to the extent of the proposed district, or both, and every person so interested shall have a right to protest on any grounds and to object to such owner's real estate being included within said district; at such hearing all objections and protests shall be heard and passed upon by the Mayor and City Council. Notice is further given that if the owners of record title representing more than 50% of the taxable valuation of all the taxable real estate included in said proposed district and who are such owners at the time of the first publication of this notice shall file with the City Clerk within 20 days of the first publication of this notice written objections to the formation of said district, said district shall not be formed. If objections are not filed as above set forth and if the Mayor and Council shall find after considering any other protests and objections that may be filed and after considering the evidence presented at such hearing that the public health, welfare, convenience or necessity require the formation of said off-street parking district and the acquisition and construction of off-street parking facilities therein, then such district shall be formed by ordinance.

Notice is further given that the engineer's estimate of the sum of money to be expended in the acquisition of property and the construction of off-street parking facilities in said district is \$164.822.00.

The highest volume of calls were car wrecks for a total of 18 out of the 53 calls. Wilson updated the Mayor and Council on equipment maintenance and equipment updating issues. Chief Wilson also thanked the Mayor and City Administrator for the time spent negotiating with the Rural Fire Board on the Interlocal Agreement.
