PLATTSMOUTH CITY COUNCIL June 6, 2011

A meeting of the City Council of the City of Plattsmouth, Nebraska was convened in open and public session at 7:00 o'clock p.m. on June 6, 2011 at City Hall in Plattsmouth Nebraska. Present were Mayor R. Paul Lambert and Council Members: John Porter, Mike Bowman, Terry D. Tilson, Steve Riese, Pat Dugan, Art Tesarek and Doug Derby. Council Members Absent: Terry Kerns. Discussion was had relating to a revised version of the redevelopment plan for certain of the properties included in Westside Commercial Addition. The City Administrator noted that no action had been taken on such plan by the Mayor and Council and that the proposed plan had been revised. The City Administrator also noted the need to provide for a hearing before the Mayor and Council upon the revised plan. RESOLUTION NO. 11-018

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, TO PROVIDE FOR A HEARING ON THE REDEVELOPMENT PLAN FOR LOTS 2 THROUGH 9 OF WESTSIDE COMMERCIAL ADDITION AND THE REFERRAL OF SUCH REVISED PLAN TO THE PLANNING COMMISSION.

BE IT RESOLVED BY THE MAYOR AND COUNCIL, as follows:

Section 1. The Mayor and Council hereby find and determine that pursuant to the provisions of the Community Development Law (Neb. Rev. Stat. §§ 18-2101 to 18-2144 (Reissue 2007), as amended, the "Act"), the Community Development Agency of the City of Plattsmouth (the "Agency") has been presented with a redevelopment plan entitled "Redevelopment Plan Plattsmouth Plaza Redevelopment Area" (the "Plan") for the following described real estate which is in an area that has been previously determined to be substandard and blighted and in need of redevelopment:

Lots 2 through 9, inclusive, Westside Commercial Addition to the City of Plattsmouth, Cass County, Nebraska, as surveyed, platted and recorded (the "Project Area").

Section 2. The Mayor and Council further find and determine that pursuant to Section 18-2115 of the Act, it is necessary to hold a public hearing on the Plan and that such Plan (as revised) should be referred to the Planning Commission for review in accordance with the Act.

Section 3. The City Clerk's actions in setting June 20, 2011 at 7:00 p.m. as the time for hearing and actions relating to publication of notice as required by law are hereby approved and confirmed.

Section 4. Referral of the revised Plan for the Project Area to the Planning Commission is hereby approved and confirmed.
