NOW, THEREFORE, BE IT RESOLVED that the following tax levy is adopted for the fiscal year October 1, 2013 through September 30, 2014 with a dollar requirement totaling \$1,323,890 based on a combined tax rate of \$.486165 per \$100.00 of taxable valuation as follows: (1) a rate of \$.044814 per \$100.00 of valuation for the bond levy in the total amount of \$132,928 and (2) a rate of \$.437718 per \$100.00 of valuation for general operating expenses in the total amount of \$1,191,962 (consisting of \$.320759 per \$100.00 of valuation for general operating expenses in the total amount of \$873,469 and \$.116958 per \$100.00 of valuation for other debt service in the total amount of \$318,493).

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA TO AUTHORIZE THE TRANSFER OF PICKLE CARD FUNDS HELD BY THE CITY FOR

THE BENEFIT OF PLATTSMOUTH VOLUNTEER FIRE DEPARTMENT TO THE PLATTSMOUTH VOLUNTEER FIREFIGHTERS ASSOCIATION TRUST FUND PURSUANT TO AND AS AUTHORIZED BY *NEB. REV. STAT.* § 9-326.

WHEREAS, *Neb. Rev. Stat.* § 9-326 authorizes any nonprofit organization holding a certificate of exemption under section 501(c)(3) of the Internal Revenue Code to have a license to conduct a lottery by the sale of pickle cards.

WHEREAS, the Plattsmouth Volunteer Firefighters Association has obtained a license to conduct a lottery by the sale of pickle cards pursuant to the Nebraska Pickle Card Lottery Act.

WHEREAS, the proceeds from the sale of pickle cards by the Plattsmouth Volunteer Firefighters Association will not be considered public funds or funds of the City for any purpose, including the Nebraska Budget Act, nor shall the City incur any liability, nor have any responsibility for, any pickle card operations conducted by the Association.

WHEREAS, all money raised by the Plattsmouth Volunteer Firefighters Association pursuant to the Nebraska Bingo Act, the Nebraska Lottery and Raffle Act, the Nebraska Pickle Card Lottery Act, and the Nebraska Small Lottery and Raffle Act shall be subject to such acts with respect to the deposit and expenditure of such money.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Plattsmouth, Nebraska that the City recognizes the Plattsmouth Volunteer Firefighters Association (Association) for the purpose of conducting a licensed pickle card lottery operation and to hold funds raised from such operation.

BE IT FURTHER RESOLVED that the Fire Chief, appointed by the Mayor and confirmed by the City Council, shall have all powers and authority as provided in Chapter 8, Article 1, of the City of Plattsmouth, Nebraska Revised Municipal Ordinances 2011.

BE IT FURTHER RESOLVED THAT the City Treasurer shall transfer all funds from the following accounts held by the City for the benefit of the Plattsmouth Volunteer Fire Department to the Association at Plattsmouth State Bank subject to being expended in compliance with the Nebraska Pickle Card Lottery Act:

BE IT FURTHER RESOLVED that the Association shall be subject to audit by the City of Plattsmouth for purposes of ensuring compliance with the Nebraska Pickle Card Lottery Act, *Neb. Rev. Stat.* §§9-301 *et seq.* 

BE IT FURTHER RESOLVED that the Association shall at all times ensure that it remains a licensed organization pursuant to *Neb. Rev. Stat.* §9-342.

BE IT FURTHER RESOLVED that the Association shall keep on file with the City Clerk a current copy of the Association's Articles of Incorporation, Internal Revenue Service "Letter of Determination," and by-laws so that City may ensure compliance with all federal, state and local laws, ordinances and regulations.

BE IT FURTHER RESOLVED that the Association shall advise City of its intended purchases so that City may decide to accept or reject the same, and if accepted upon purchase of such equipment Association shall provide the same to City which shall then place the same in City's inventory of equipment to be insured.

BE IT FURTHER RESOLVED that the determination of City to either accept or reject any proposed purchase shall be decided as follows: a) by the City Administrator for purchases up to \$20,000, and b) by the City Council for purchases in excess of \$20,000.
