**WHEREAS** it is in the best interests of the City of Plattsmouth that the amount of the property tax request for the current fiscal year be a different amount than the property tax request for the prior year.

**NOW, THEREFORE, BE IT RESOLVED** that the tax levy is adopted for the fiscal year October 1, 2009 through September 30, 2010 with a dollar requirement totaling \$1,305,433.00 and that the property tax levy be set at \$.439916 per \$100.00 of valuation;
