NEW BUSINESS

ITEM 9 A

Chris Koenig, HDR, Inc. reviewed the plans for the separation of the Combined Sewer Overflow and the Main Street Area Sidewalk, Street and Parking Lot Public Improvements. Koenig stated that the plans and specifications were complete and the project was ready to be put out for bids. Vickie Huddleston questioned if there would be added expense for snow removal with the streetscape design and Portis answered No, it has been researched and we have a plan. Doug Duey, member of the Main Street Design Committee stated that he felt that this was one of the most progressive moves within the City and that Main Street is the heart of a smaller community and through major improvements the community will be stronger and you will see incremental improvements in the immediate surrounding area. Duey also stated that projects like this can provide tremendous Economic Stimulus and shows faith in the Community.

ITEM 9 B

Motion by Derby, seconded by Porter to approve the plans for the separation of the Combined Sewer Overflow and the Main Street Area Sidewalk, Street and Parking Lot Public Improvements

as presented. Council Member Jenkins questioned that many items within this project should not be included in the .05% sales tax and the end result will include more work and maintenance when there is no money to give raises to the employees. City Administrator Erv Portis stated that the current programs are not sustainable and it is felt that this project is the right starting point and the project is within the adopted comprehensive plan. Council Member Tilson stated that he also has concerns but anticipates that this project will give a new face for the community. Council Member Bowman stated that he felt that the project will stimulate for the future. Council Member Wassinger stated that we have to look at this project objectively-we are still preserving the historical nature of main street but this is an opportunity to do it right-the whole process instead of just a "band-aide". Wassinger also stated that if we start with downtown that soon you will see new energy and revitalization for the community. Council Member Derby felt that perhaps we are the front door to Nebraska and we can appeal to and become a destination point for businesses and tourists. Doug Duey, Main Street Design Committee Member stated that the questions and concerns are legitimate but we have to look at reality-make downtown more pedestrian friendly and the retail and sales tax dollars will blossom. ROLL CALL: Yes-Bowman, Tilson, Wassinger, Tesarek, Derby, Porter and Kerns. No-Jenkins. Absent-None. Abstain-None. MOTION CARRIED.

Motion by Wassinger, seconded by Bowman to authorize the solicitation of bids for the Combined Sewer Overflow (Schedule A) and the Main Street Area Sidewalk, Street and Parking Lot Public Improvements (Schedule B). ROLL CALL: Yes-Kerns, Bowman, Tilson, Wassinger, Tesarek, Derby and Porter. No-Jenkins. Absent-None. Abstain-None. MOTION CARRIED.

ITEM 9 D

Motion by Bowman, seconded by Wassinger to approve authorization for rehabilitation project, #PLATTS-OOR-001, 2212 Andies St., to North Star Construction with a base bid of \$13,753.41, an alternate bid of \$8,337.75; for a total not to exceed \$24,000.00 and authorize the Mayor to execute the contract. Council member Kerns questioned if local contractors were notified-Portis stated that none of the local contractors were EPA Lead Paint Certified but they are notified. ROLL CALL: Tesarek, Derby, Porter, Kerns, Bowman, Tilson, Wassinger and Jenkins. No-None. Absent-None. Abstain-None. MOTION CARRIED.

Erv Portis, City Administrator reviewed prior informal conversations with Cass County regarding the City assuming responsibility for River Road if Cass County paves the road. Portis recommended to not assume the responsibility as there is no revenue for maintenance. No Action Taken.
