Motion by Bowman seconded by Wassinger to adopt Resolution No. 10-018:. Mr. Johnson read said Resolution into the record.

RESOLUTION NO. 10-018

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA, AMENDING RESOLUTION 10-001 RELATED TO SPECIAL ASSESSMENTS AGAINST REAL ESTATE FOR IMPROVEMENTS AND AUTHORIZING THE CITY CLERK TO FILE THE SAME WITH THE CASS COUNTY TREASURER AND CASS COUNTY CLERK.

WHEREAS, the City Council previously imposed special assessments on the following properties but subsequently discovered that title to 608 South 8^{TH} Street had transferred prior to the public hearing:

608 South 8TH Street \$116.62 804 North 9TH Street \$595.08

WHEREAS, the City desires to proceed with the levy of the special assessment on 804 North 9TH Street.

NOW, THEREFORE, BE IT RESOLVED that Resolution 10-001 is amended as follows:

WHEREAS, the property owners of 804 North 9TH Street, Plattsmouth, Nebraska, legally described as Lot 12, Block 5, Townsend's Addition to the City of Plattsmouth, Cass County, Nebraska failed to abate a nuisance condition and the City expended \$595.08 to complete the abatement which the owners then failed to pay; and

WHEREAS, a public hearing was held and evidence was received and considered by the Mayor and City Council sitting as a Board of Adjustment and Equalization related to the special benefit to the property from the nuisance abatement.

NOW, THEREFORE, BE IT RESOLVED that the City Council finds and

determines that the following property specially benefitted from the City's abatement of a nuisance on the property: Lot 12, Block 5, Townsend's Addition to the City of Plattsmouth, Cass County, Nebraska.

BE IT FURTHER RESOLVED that the cost of the clean up is a correct statement of special benefit to the property and that there be and hereby is levied against the property \$595.08 which shall be due in a single payment not later than September 20, 2011, at which time the assessment shall be delinquent.

BE IT FURTHER RESOLVED that this special assessment shall become due on or before September 20, 2010, which is more than fifty days after the date of the public hearing and may be paid within that time without interest. If not paid by said date, interest shall accrue at the rate of seven percent (7%) per annum until paid, and if not paid by the delinquency date, interest shall accrue at the rate of nine percent (9%) per annum until paid.

BE IT FURTHER RESOLVED that the City Clerk shall certify a copy of this levy to the County Clerk and County Treasurer of Cass County, Nebraska for spreading the same on the tax records of the County and special assessments shall be collected by the County Treasurer as provided by law.
