RESOLUTION NO. 11-008

A RESOLUTION TO DIRECT THE WAY IN WHICH FUNDS OF THE CITY OF PLATTSMOUTH ARE HELD AND THE ELECTED AND APPOINTED OFFICIALS AUTHORIZED TO WITHDRAW SAID FUNDS.

WHEREAS, the City has been issued a employer identification number by the Internal Revenue Service;

WHEREAS, the City uses its employer identification number to open accounts in which City funds are held;

WHEREAS, *Neb. Rev. Stat.* § 16-318 provides that the City Treasurer shall be the custodian of all funds belonging to the City; and

WHEREAS, *Neb. Rev. Stat.* § 16-718 requires that draws upon the treasury must be signed by the mayor and countersigned by the clerk.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Plattsmouth, Nebraska that all accounts carrying the City's employer identification number are City funds.

BE IT FURTHER RESOLVED that the City Treasurer shall be the sole custodian of all City funds.

BE IT FURTHER RESOLVED that only the Mayor shall be authorized to sign, subject to the countersignature of the City Clerk, draws upon the treasury which are identified as City funds by way of the use of the City's employer identification number.

ITEM 9 G

Motion by Derby, seconded by Tesarek to approve the request from First Lutheran Church for the closing of North 10th Street from Webster Blvd. north to Avenue D on Saturday, April 30, 2011 from 8:00 a.m. to 4:00 p.m. for a Health Fair contingent upon the First Lutheran Church submitting proof of insurance for the event naming the City of Plattsmouth as an additional insured in the prescribed amount required by the City. ROLL CALL: Yes-Tilson, Riese, Dugan, Tesarek, Derby and Porter. No-None. Absent-Kerns and Bowman. Abstain-None. MOTION CARRIED.

ITEM 9 H

Council member Tilson asked that Fire Chief Mike Wilson speak regarding the Fire Department Dive Team. Chief Wilson stated that he was notified in October 2010 the Lewis Township Dive Team was disbanding and beings the City only has a pond the Rural Fire Board purchased the equipment from them. A dive team would not be covered on the Missouri River but the Lewis Township equipment would be an addition to the equipment already possessed by the Plattsmouth Fire Department. A Dive Team would be looked in to in the future. Wilson also noted that the Rural Fire Board would establish an annual budget item for the newly purchased equipment. Council Member Tilson stated that the Missouri River is very dangerous and he would prefer to not send our guys out on it. Erv Portis, City Administrator stated that he has been in contact with EMC Ins. and EMC is prepared to issue Change Endorsements to include Longshore and Harbor Workers' Compensation at no additional cost. Property and liability change endorsements will also be issued once the Chief prepares a detailed list of inventory to be insured. Rural Fire will be invoiced for any new costs. Portis also stated that if the Council chooses to move forward that the Fire Department/Rural Fire Board should come back to Council with a detailed plan. Council Member Tilson stated that if the Council chooses to move forward it will be one of the toughest things the department will ever do and the department must be prepared to practice all the time. Council Member Riese clarified that this would be a diving and watercraft operation and that currently we have a watercraft operation.

ITEM 9 I

City Administrator Erv Portis reviewed the format of the current agendas. Portis suggested streamlining the items so be more efficient. Tilson suggested that appointments to position of authority should be outside of the consent agenda. Council asked to see examples.

ITEM 9 J

City Administrator Erv Portis stated that a formal application/permit for requesting a street closing would be more efficient. After discussion, it was decided that a draft resolution or ordinance will be presented to Council for further consideration
