CUMMINS CENTRAL POWER CLAIM

Erv Portis, City Administrator advised that Council authorized purchase of a Portable Emergency Generator from Cummins Central Power. The City has a NDHHS grant of \$10,000 conditioned on receipt, acceptance, and payment by June 30, 2014. Contract with Cummins required delivery and acceptance by June 6, 2014. The City has not yet taken delivery and upon delivery staff will need to assure bid specifications regarding design and performance have been met. Approval of the claim is recommended conditioned on receipt, acceptance, and performance per bid specifications. If Council approves as recommended, Cummins will not be paid until the unit is delivered and accepted. If Cummins failure to perform as required by contract causes the City to lose the NDHHS grant award, the City should seek liquidated damages as specified in the bid award and contract.
