WHEREAS, the City of Plattsmouth acknowledges and accepts the duties set out in Neb. Rev. Stat. § 39-1359(2) and, if a claim is made against the State, the City shall indemnify, defend and hold harmless the State from all claims, demands, actions, damages, and liability, including reasonable attorney's fees, that may arise as a result of a special event.

WHEREAS, a portion of United States Highway 34 also known as Main Street; a portion of United Stated Highway 34 also known as South 6th Street from Main Street to 1st Avenue and 1st Avenue to Chicago Avenue; and a portion of United States Highway 34 also known as South 3rd Street from Main Street to 2nd Avenue, all located within the corporate limits of the City of Plattsmouth.

WHEREAS, the City must notify the Nebraska Department of Roads of a proposed closure of a State Highway or United States Highway under its control and jurisdiction, and the City must agree to indemnify the State of Nebraska.

WHEREAS, Plattsmouth Chamber of Commerce has requested the closure of US Highway 34, also known as Main Street, from 3rd Street to 6th Street on October 3, 2014 for a special event (Cruizin Main) from 10:00 a.m. to 10:00 p.m.; South 6th Street from Main Street to 1st Avenue on October 3, 2014 from 10:00 a.m. to 10:00 p.m.; and South 3rd Street from Main Street to 2nd Avenue on October 3, 2014 from 10:00 a.m. 10:00 p.m.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Plattsmouth, Nebraska that, US Highway 34 be closed: Main Street, from 3rd Street to 6th Street on October 3, 2014 for a special event (Cruizin Main) from 10:00 a.m. to 10:00 p.m.; South 6th Street from Main Street to 1st Avenue on October 3, 2014 from 10:00 a.m. to 10:00 p.m.; and South 3rd Street from Main Street to 2nd Avenue on October 3, 2014 from 10:00 a.m. 10:00 p.m. and that the City of Plattsmouth accepts the duties set out in Neb. Rev. Stat. § 39-1359(2), if a claim is made against the State, the City shall indemnify, defend and hold harmless the State from all claims, demands, actions, damages, and liability, including reasonable attorney's fees, that may arise as a result of a special event, and so notify the Nebraska Department of Roads.
