#### ITEM 8 A

Pursuant to publication, Mayor Lambert opened a public hearing at 7:02 p.m. to hear and consider public comment concerning an existing Community Development Block Grant (CDBG #13-CIS-104 Street Project) awarded to the City. Craig Eberle, Interim Executive Director of SouthEast Nebraska Development District (SENDD) stated that this is the second required public hearing on the project and the project is now complete. Improvements included street paving, drainage and water main repairs. Of the CDBG funds, \$230,000.00 was available for Street/Bridge activity; and \$20,000.00 available for project administrative costs. The City matched the grant with up to \$250,000.00 to make the improvements. No one else spoke. Mayor Lambert closed the public hearing at 7:03 p.m.

## ITEM 8 B

Pursuant to publication, Mayor Lambert opened a public hearing at 7:04 p.m. to hear and consider public comment concerning an existing Community Development Block Grant (CDBG #14-CIS-004 Street Project) awarded to the City. Craig Eberle, Interim Executive Director of SouthEast Nebraska Development District stated this is the second required public hearing on the project. It is Phase II of the project for which the City was awarded \$210,000.00 in CDBG, Comprehensive Investment & Stabilization (CIS) Category to conduct street and water line improvements within the targeted census tract areas located in Plattsmouth. \$195,000.00 will be available for Street activity; \$15,000.00 will be available for project administrative costs;

City will match the grant with at least \$195,000.00 to make the improvements. No one else spoke. Mayor Lambert closed the public hearing at 7:05 p.m.

## ITEM 9 A

Pursuant to publication, Mayor Lambert opened a public hearing at 7:06 p.m. to hear and consider public comment concerning the proposed revisions (update the housing income limits of the plan to match the 2016 US Department of Housing and Urban Development) to the Plattsmouth, Nebraska Community Development (CDBG) Program Income Housing Development Reuse Plan. Craig Eberle, Interim Executive Director of SouthEast Nebraska Development District stated the City of Plattsmouth intends to revise the reuse plan to update the housing income limits of the plan to match the 2016 U.S. Department of Housing and Urban Development housing income limits. These changes will allow for more flexability and use with the Downtown Revitalization (DTR). No one else spoke. Mayor Lambert closed the public hearing at 7:08 p.m.

## ITEM 9 B

Pursuant to publication, Mayor Lambert opened a public hearing at 7:08 p.m. to hear and consider public comment concerning the use of \$45,000.00 of Community Development Block Grant – Economic Development Loan Fund (CDBG-EDLF) funding for financing under the approved City of Plattsmouth, Nebraska Economic Development Plan for use of Community Development Block Grant Program Income. Craig Eberle, Interim Executive Director of SouthEast Nebraska Development District stated that these funds would be used to provide "Providence Pizza, LLC" a "Reuse Loan" to assist with the purchase of inventory for a small business start-up including leasehold improvements, the purchase of equipment, furniture and fixtures as well as start-up working capital expenditures. The business will be required to create three (3) full time equivalent (FTE) job positions as a result of the performance based financing. The total project cost is \$476,500.00 and the participating lender and the proposed owners will be providing the remaining \$431,500.00 of the project costs. The project is located at 16401 Westside Drive, Plattsmouth. Mr. Eberle also reviewed the benefits of using a Non-profit Development Organization (NDO), which SEND, Inc. is one, and stated that the Nebraska Department of Economic Development strongly encourages using an NDO. No one else spoke. Mayor Lambert closed the public hearing at 7:15 p.m.

#### ITEM 9 C

# To Use Community Development Block Grant (CDBG) Program Income from the Economic Development Loan Fund (EDLF) Under the approved Economic Development Plan

**WHEREAS**, the City of Plattsmouth Nebraska, has adopted an "Economic Development Plan" for use of Community Development Block Grant (CDBG) Program Income funds from previous CDBG projects; and

**WHEREAS**, funds collected under the Economic Development Loan Fund (EDLF) are to be used for projects or programs providing direct or indirect financial assistance to qualifying businesses; and

WHEREAS, the Economic Development Application Review Committee has recommended a project, presented through application by an eligible business, for a "Reuse Loan" of \$45,000.00 under specified conditions; the project financing needs include the establishment of a new Little Caesar's pizza franchise in Plattsmouth. This includes leasehold improvements, the purchase of equipment, furniture and fixtures, and inventory, as well as start-up working capital expenditures. Total project costs = \$476,500.00. The business has secured an additional \$431,500.00 of project funding through a commitment of funds from a participating lender and the proposed owners; and,

**WHEREAS**, the City of Plattsmouth, Nebraska has obtained its citizens' comments on community development and housing needs; and has conducted a public hearing upon the proposed use of the CDBG EDLF financing; all of the CDBG EDLF funds will be used for activities that will meet the CDBG National Objective of benefiting low-to-moderate income persons and will create at least 3 full time equivalent (FTE) jobs,

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Plattsmouth, Nebraska, that approval of the application and obligation of funds is authorized according to the recommendations of the Economic Development Application Review Committee, and the Mayor of the City of Plattsmouth is hereby authorized to proceed with the formulation of any and all contracts, documents or other memoranda, as well as execute all necessary and appropriate documents on behalf of the City of Plattsmouth prior to closing on the project for "**Providence Pizza, LLC**", contingent upon approval of the City Attorney as to form.

Whereas, Article III, Section 4-303 of the City of Plattsmouth Revised Municipal Code provides that

The City Council, may, by resolution, set aside any street, alley, public way or portion thereof where the parking of a particular kind or class of vehicle shall be prohibited or where the parking of any vehicle shall be prohibited. No vehicle prohibited from parking thereon shall stand or be parked adjacent to the curb of said street, alley, public way or portion thereof longer than a period of time necessary to load and unload freight or passengers.

Whereas, 7<sup>th</sup> Street between 4<sup>th</sup> Avenue and 5<sup>th</sup> Avenue is twenty-four feet wide from curb to curb and parking of vehicles on both sides of 7<sup>th</sup> Street presents a public safety hazard. THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL that parking on the east side of 7<sup>th</sup> Street between 4<sup>th</sup> Avenue and 5<sup>th</sup> Avenue shall be prohibited as provided in Article III, Section 4-303 of the City of Plattsmouth Revised Municipal code.
