Council Member Kerns introduced a resolution numbered and titled as follows: RESOLUTION NO. 17-005: RESOLUTION OF THE CITY OF PLATTSMOUTH TO VACATE THE CASTAWAY ESTATE PLAT, CASTAWAY VILLA PLAT, CASTAWAY COTTAGE PLAT, AND MOREHEAD ISLAND PLAT, SEEK RELEASES FROM THIRD PARTIES PROVIDED INTERESTS BY THOSE OLD PLATS, VACATE THE SANITARY SEWER DISTRICT, AND ASSUME THE OBLIGATION TO MAINTAIN THE CULVERT EASEMENT ALL AS IT RELATES TO THE PROPERTY AND THE DESCRIPTION OF THOSE TERMS AS SET FORTH HEREIN.

Motion by Kerns, seconded by Porter to adopt RESOLUTION NO. 17-005:

RESOLUTION NO 17-005

RESOLUTION OF THE CITY OF PLATTSMOUTH TO VACATE THE CASTAWAY ESTATE PLAT, CASTAWAY VILLA PLAT, CASTAWAY COTTAGE PLAT, AND MOREHEAD ISLAND PLAT, SEEK RELEASES FROM THIRD PARTIES PROVIDED INTERESTS BY THOSE OLD PLATS, VACATE THE SANITARY SEWER DISTRICT, AND ASSUME THE OBLIGATION TO MAINTAIN THE CULVERT EASEMENT ALL AS IT RELATES TO THE PROPERTY AND THE DESCRIPTION OF THOSE TERMS AS SET FORTH HEREIN.

WHEREAS, the City of Plattsmouth ("City") desires to sell the property legally described on Exhibit A (the "Property") to One Schmore, LLC ("Schmore") in accordance with the terms of the certain Purchase Agreement attached as Exhibit B;

WHEREAS, Schmore has obtained a title commitment ("Commitment") for a title insurance policy (the "Policy") from Old Republic National Title Insurance Company ("Old Republic") which currently contains exceptions from coverage under the proposed Policy listed in Schedule B, Section 11, including, but not limited to, items 10, 14, 16, 18, 19 and 20 governing the following:

- 1. Exception 10: Terms and Conditions of Plat for Castaway Estates filed June 20, 2008 as Book 63 Misc, Page 325 Cass County, Nebraska ("Castaway Estate Plat");
- Exception 14: Terms and conditions of Plat for Castaway Villas filed July 29, 2008 in Book 63 Misc, Page 332 Cass County, Nebraska ("Castaway Villa Plat");
- 3. Exception 16: Terms and conditions of Plat for Castaway Cottages filed May 19, 2010 in Book 63 Misc, Page 451 Cass County, Nebraska ("Castaway Cottage Plat");
- 4. Exception 18: Terms and conditions of Plat for Morehead Island Riverfront Development filed August 8, 2003 in Book 53 Misc., Page 475 Cass County, Nebraska ("Morehead Island Plat");
- 5. Exception 19: Terms and conditions of Easement Agreement filed December 14, 1990 in Book 39 Misc., Page 514 Cass County, Nebraska (the "Culvert Easement"); and
- 6. Exception 20: Terms and conditions of Easement to City of Plattsmouth for Interceptor Sewage Pipeline filed April 29, 1972 in Book 19 Misc., Page 442 Cass County, Nebraska (the "Sanitary Sewer Easement");

WHEREAS, as the City has replatted the Property in connection with the sale with the intention of replacing the Castaway Estate Plat, Castaway Villa Plat, Castaway Cottage Plat, and Morehead Island Plat (herein collectively, the "Old Plats") as it relates to the Property;

WHEREAS, the Culvert Easement purports to grant a drainage easement in favor of a dominant estate therein described relating to an engineered culvert which culvert was then constructed on land lying outside the Property as depicted on Exhibit C attached to this Resolution (herein the "Culvert");

WHEREAS, the Sanitary Sewer Easement purports to grant the City an Interceptor Sewer Easement on the Property as depicted on Exhibit D attached to this Resolution (the "Sanitary Sewer Easement");

WHEREAS, Schmore desires the Old Plats, Culvert Easement and Sanitary Sewer Easement to be removed as exceptions to the Policy;

WHEREAS, Old Republic is willing to remove the Old Plats as exceptions to the Policy if the City vacates those Old Plats and obtains releases of easements granted to third parties as depicted on Exhibit D or otherwise listed as dedications on the Old Plats;

WHEREAS, Old Republic is willing to remove the Culvert Easement as an exception to the Policy provided that the City agrees to maintain the Culvert in the manner prescribed in the Culvert Easement in the event Schmore is found to be legally obligated to maintain the Culvert;

WHEREAS, Old Republic is willing to remove the Sanitary Sewer Easement as an exception to the Policy if the City vacates the Sanitary Sewer Easement;

WHEREAS, the City is willing to vacate the Old Plats as it relates to the Property because of its approval of the new plat for the Property provided as a condition of sale;

WHEREAS, the City is willing to accept responsibility to maintain the Culvert so as to have the Easement Agreement removed as an exception to the Policy;

WHEREAS, the City is willing to vacate the Sanitary Sewer Easement since the City opted not to utilize the Sanitary Sewer Easement in constructing the interceptor for the Sanitary Sewer system;

NOW, THEREFORE, the City resolves as follows:

RESOLVED, that the City hereby vacates the Old Plats as it relates to the Property in favor of the new plat for the Property and will seek to obtain releases of easements/interests in the Property provided in those Old Plats as depicted on Exhibit D or otherwise listed as dedications on the Old Plats;

RESOLVED, that the City hereby agrees to assume any legal obligation that Schmore has as title owner to the Property to maintain the Culvert in the manner required by the Culvert Easement.

RESOLVED, that the City hereby	vacates the Sanitary Sewer Easement.
