Government entities involved in this project are: Nebraska Department of Roads, Metropolitan Area Planning Agency-Federal, Metropolitan Area Planning Agency-Local, City of Bellevue, Cass County Nebraska, Lower Platte South Natural Resource District, City of Plattsmouth, Papio-Missouri River Natural Resource District, Nebraska Game and Parks and Sarpy County Nebraska. Current construction on the Platte River Bridge makes it an opportune time to move forward with this project.
