July 17, 2017

A meeting of the City Council of the City of Plattsmouth, Nebraska was convened in open and public session at 7:00 o'clock p.m. on July 17, 2017 at Plattsmouth City Hall in Plattsmouth Nebraska. Present were Mayor R. Paul Lambert and Council Members: John Porter, Terry Kerns, Jeanie Brookhouser, Cheryl Grimshaw, Steve Riese, Joe Dugan, Wanda Wiemer and Doug Derby. Council Members Absent: None. Also present: City Administrator Ervin Portis, City Clerk Sandra J. Meyer and City Attorney Larry Welch Jr.

Notice of this meeting was given in advance by publication in the Plattsmouth Journal. Proof of publication along with the Mayor and Council's Acknowledgment of Receipt of Notice are on file. All proceedings hereafter shown were taken while the convened meeting was open to the public.

The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act and a copy of all documents being discussed at the meeting were available for inspection and indicated the location of such copies in the room where the meeting was being held.

ITEM 6

A video, made by Nebraska Public Power District, of the June 16, 2017 Plattsmouth storm damage was shown. Mayor Lambert introduced representatives of Nebraska Public Power District (NPPD): Pat Pope, NPPD CEO; Mary Harding, NPPD Board Member; Craig Vincent, NPPD District Account Manager; and Mick Snell, NPPD Distribution Supervisor-Plattsmouth, and thanked them for the quick and professional response to the power outage issues due to the June 16, 2017 storm.

Council member Wiemer introduced a resolution numbered and titled as follows: RESOLUTION NO. 17-006: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF PLATTSMOUTH, NEBRASKA EXPRESSING APPRECIATION TO THE NEBRASKA PUBLIC POWER DISTRICT AND ITS EMPLOYEES FOR THEIR RESPONSE TO THE JUNE 16, 2017 STORM THAT DAMAGED MANY HOMES, BUSINESSES, AND PUBLIC PROPERTY AND LEFT MANY PLATTSMOUTH RESIDENTS WITHOUT ELECTRICITY FOR SEVERAL DAYS.

Motion by Wiemer, seconded by Derby to adopt RESOLUTION NO. 17-006:

RESOLUTION NO. 17-006

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF PLATTSMOUTH, NEBRASKA EXPRESSING APPRECIATION TO THE NEBRASKA PUBLIC POWER DISTRICT AND ITS EMPLOYEES FOR THEIR RESPONSE TO THE JUNE 16, 2017 STORM THAT DAMAGED MANY HOMES, BUSINESSES, AND PUBLIC PROPERTY AND LEFT MANY PLATTSMOUTH RESIDENTS WITHOUT ELECTRICITY FOR SEVERAL DAYS.

- **WHEREAS**, the City of Plattsmouth and Nebraska Public Power District (NPPD) have partnered for more than forty years to provide electricity to customers within the Plattsmouth electric utility service area;
- **WHEREAS**, on January 1, 2004, the City of Plattsmouth and NPPD ratified a Professional Retail Operations Agreement through which NPPD operates and maintains the electric utility for Plattsmouth;
- **WHEREAS**, in March 2017, Plattsmouth and NPPD ratified Amendment No. 2 to the Professional Retail Operations Agreement through which NPPD will operate and maintain the electric utility for Plattsmouth through at least March 2032;
- **WHEREAS**, in the evening of June 16, 2017 a devastating spring storm rolled through Plattsmouth damaging many homes, businesses, and public property, and left 2800 NPPD Plattsmouth area customers without power;
- **WHEREAS**, immediately upon being notified of the power emergency, NPPD dispatched line crews from York, South Sioux City, Kearney, Norfolk, and other communities to assist its Plattsmouth area crews, some of whose own homes were damaged by the storms;
- **WHEREAS**, by midnight of June 16th, NPPD had already restored power to the water treatment plant, wastewater plant, and other critical city infrastructure, by 7:00 p.m., the following day, the 2800 customers without power had been reduced to 480; and by Monday afternoon almost all customers had their power restored;
- **WHEREAS**, even while working to restore power, NPPD linemen Ed Boyle and Doug Bauer noticed a Plattsmouth resident providing aid to a neighbor who had become weak and was having difficulty staying upright without support, and both Boyle and Bauer put aside what they were doing to help get the resident and her neighbor inside to safety;
- **WHEREAS**, NPPD'S commitment to reliability and a quality relationship with its customers was never more evident than in helping Plattsmouth recover from this storm;
- **THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF PLATTSMOUTH, NEBRASKA** that, on behalf of our citizens and constituents, NPPD is recognized and graciously thanked for its long-standing relationship with this community and for its assistance following the June 16, 2017 damaging storm and winds.
