Council member Kerns introduced an ordinance numbered and titled as follows: **ORDINANCE NO. 1938 AN ORDINANCE OF THE CITY OF PLATTSMOUTH, NEBRASKA TO AMEND ARTICLE IV, CHAPTER 4 OF THE PLATTSMOUTH REVISED MUNICIPAL ORDINANCES OF 2011, SPECIFICALLY TO REPEAL SECTIONS 4-415 TO 4-422 RELATING TO THE USE OF ALL-TERRAIN VEHICLES IN THE CITY, TO REPLACE THESE REPEALED SECTIONS WITH NEWLY ENACTED SECTIONS 4-415 TO 4-422 RELATING TO THE USE OF ALL-TERRAIN VEHICLES AND UTILITY-TYPE VEHICLES IN THE CITY, TO ENACT SECTIONS 4-433 TO 4-438 RELATING TO THE USE OF GOLF CAR VEHICLES IN THE CITY; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE.**

Motion by Kerns seconded by Brookhouser to approve Second Reading of ORDINANCE NO. 1938 by title only with the removal of the following language in SECTION 4-416 (e): provided any such

passenger shall wear a protective helmet which meets the motorcycle helmet standard of the State of Nebraska. Following discussion on the intent of travel, ROLL CALL: Yes-Porter, Brookhouser, Riese, Wiemer, Derby and Kerns. No-Minahan and Grimshaw. Absent-None. Abstain-None. MOTION CARRIED. ITEM 9 A

Council member Grimshaw introduced a resolution numbered and titled as follows: RESOLUTION NO. 18-005: WHEREAS SECTION 4-303 OF THE PLATTSMOUTH REVISED MUNICIPAL ORDINANCES OF 2011 PROVIDES THAT THE CITY COUNCIL MAY BY RESOLUTION SET ASIDE ANY STREET OR PORTION THEREOF WHERE PARKING OF ANY VEHICLE SHALL BE PROHIBITED.

Motion by Grimshaw seconded by Riese to adopt RESOLUTION NO. 18-005:

RESOLUTION NO. 18-005

WHEREAS SECTION 4-303 OF THE PLATTSMOUTH REVISED MUNICIPAL ORDINANCES OF 2011 PROVIDES THAT THE CITY COUNCIL MAY BY RESOLUTION SET ASIDE ANY STREET OR PORTION THEREOF WHERE PARKING OF ANY VEHICLE SHALL BE PROHIBITED;

WHEREAS THE CITY’S PUBLIC WORKS DIRECTOR HAS IDENTIFIED POTENTIAL TRAFFIC HAZARDS ON PORTIONS OF SEVERAL CITY STREETS WHICH HAZARDS COULD BE MITIGATED BY PROHIBITING PARKING ON THE SAME; AND

WHEREAS THE CITY COUNCIL HAS DETERMINED IT IS IN THE INTEREST OF PUBLIC SAFETY TO IMPOSE PARKING RESTRICTIONS ALONG SUCH PORTIONS OF THE CITY’S STREETS.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA:

That hereafter, the parking of any vehicle shall be prohibited along the following City streets and “No Parking” signage shall be posted as indicated below:

- (1) East Main Street from Schilling Road to the public boat ramp area. No parking signage shall be posted on both sides of the street for pedestrian safety.
- (2) The west side of 17th Street from 3rd Avenue to Avenue A. No parking signage shall be posted on the west side of 17th Street.
- (3) The north and east sides of Andies Street from Lincoln Avenue to South 15th Street. No parking signage shall be posted on the north and east sides of Andies Street.

- (4) The south side of Second Avenue from Chicago Avenue to South 7th Street. No parking signage shall be posted on the south side of Second Avenue.
- (5) The south side of 6th Avenue from 1st Street to 2nd Street. No parking signage shall be posted on the south side of 6th Ave.
- (6) The east side of North 7th Street from Avenue A to Avenue B. No parking signage shall be posted on the east side of North 7th Street.
- (7) The south side Avenue F from North 10th Street to North 11th Street. No parking signage shall be posted on the south side of Avenue F.

This Resolution shall be in full force and effect after the posting of signs upon the street as herein designated.

Motion by Brookhouser seconded by Grimshaw to adopt RESOLUTION NO. 18-006:

RESOLUTION NO. 18-006

WHEREAS SECTION 4-320 OF THE PLATTSMOUTH REVISED MUNICIPAL ORDINANCES OF 2011 PROVIDES THAT THE CITY COUNCIL MAY BY RESOLUTION DESIGNATE ONSTREET PARKING SPACES FOR THE EXCLUSIVE USE OF HANDICAPPED OR DISABLE PERSONS; AND

WHEREAS THE CITY COUNCIL HAS DETERMINED THAT A NEED EXISTS FOR ONE SUCH DESIGNATED PARKING SPACE BETWEEN MAIN STREET AND FIRST AVENUE.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PLATTSMOUTH, NEBRASKA:

That hereafter, one parking space shall be designated at the following location for the exclusive use of handicapped or disabled persons: Sixth Street, between Main Street and 1st Avenue, on the west side of Sixth Street; and

That the Public Works Director shall designate the specific location of the parking space and shall cause signage to be posted at such location in accordance with City Ordinances.

This Resolution shall be in full force and effect after the posting of signs upon the street as herein designated.
