PLATTSMOUTH CITY COUNCIL

April 15, 2019

A meeting of the City Council of the City of Plattsmouth, Nebraska was convened in open and public session at 7:00 o'clock p.m. on April 15, 2019 at Plattsmouth City Hall in Plattsmouth Nebraska. Present were Mayor R. Paul Lambert and Council Members: Wanda Wiemer, Morgan Muller, Sean Minahan, Terry Kerns, Cheryl Grimshaw, Doug Derby and Jeanie Brookhouser. Council Members Absent: Steve Riese. Also present: City Administrator Ervin Portis, City Clerk Sandra J. Meyer and City Attorney Stephen Q. Preston.

This is a regular meeting of the Mayor and City Council of Plattsmouth. Notice of meeting was published on April 4, 2019 in the Plattsmouth Journal. Proof of publication along with the Mayor and Council's Acknowledgment of Receipt of Notice are on file. The Open Meetings Act is posted on the bulletin board in the City Council chambers. A copy of the agenda and all documents to be discussed is available to the public. All proceedings hereafter shown were taken while the convened meeting was open to the public. We will follow the agenda that was made available to the public. Please silence cell phones.

ITEM 5-CITIZEN DELEGATION

Council member Steve Riese arrived at 7:10 p.m.

Shauna Morehead-Did not think the removal of items at the cemetery was handled correctly. Have 3 children buried there-items have been left on the headstone and a cross necklace is hanging on one stone and these items should be left alone. Will care for her family's graves.

Jamie Lesley-Stated that what was done at the cemetery was a disgrace. Presented an Agreement to Care for Personal Sites which she would like reviewed and possibly something similar could be used.

Karen Johnson-Son passed in 2006. Obtained approval to cement a pole at the headstone and a small statute on the headstone. Willing to care for her graves. Hope the City can come to some agreement.

Marcia Bryant-Father passed March 22, 2018. Monument on wrong grave-on 2D and he is buried in 2E. Bench has been removed. Spoke to everyone at City Hall and nothing has been done.

Greg Hughes-Working over the past 10 days-determine how happened and how it could have been prevented. Referenced conversations with a council member, the city administrator and the person in charge of the cemetery. Reviewed the City organizational chart and the concern of the Cemetery Board not meeting and felt a cemetery board would be an intermediary. Concerns regarding the cemetery fund and where the monies are being spent. If the mayor and city council cannot replace the city administrator, I will proceed on May 1 with filing a petition with the Cass County Election Office to recall the mayor. (Provided a copy of the text he read from)

Linda Todd-Plattsmouth native. Questioned who is in charge? Who makes these decisions? Sorry doesn't get it this time. Why was it done this way? What is next for the items that were removed? (Presented a picture collage of the items that were laid out at the cemetery)

Robert L. Cook-Live in Plattsmouth for 50 years and have never seen anything as despicable as this; can't fathom the removal, breaking of items. There was an expensive item on a loved ones grave and now they cannot find it. Used to have a Cemetery Board until Portis took a way-now he makes all the rules. Crews used to keep in very good condition, now staff is at Rhylander. It is time for changes-start at the top.

Tami Gibson-Been watching Portis and he is looking down and writing-at least look at us when we are talking. Son & neice are buried there-cemetery worker made a bench. Their deaths were a huge impact on the community. Heartless. Why couldn't something have been posted on social media. I don't understand. Apology or lack of was too late.

Linda Worlein-Family buried at the cemetery are precious. Me personally lost a bowling pin-it was on the headstone. Hard to get a hold of Council Members. Never been ashamed of this town-I can't defend this. Heartless, cruel, inhumane. Teens asked why-lost sister, classmate.

Shelley Brugger-Last September weeds were up to your knees-due to so much rain. Using as an excuse for this time is ridiculous. Was a business owner with signage for parking on the street and it was never enforced even after calling. The cemetery needs to be taken care of.

Anne Colvin-Dudek-Not acceptable-many have voiced their opinion. Your responsibility to take care of the cemetery. Very sorry it happened. Very sorry for the heartbreak. The Cemetery Board needs to meet. Decades of precedence-leaving items on graves. Find some type of solution.

Tammy Lanum-Disgraced: Ordered for workers to remove veteran medallions/flags. This is disrespecting ones in the service.

Jamie Kinkaid-Not discounting that people lost something. The rules were in place a long time ago and the city is now enforcing. Communication should have been put out to everyone. Focus on water, bonds-these things are important. Stop being angry and find the change.

R. Jerry Moore-His mother's grave had flower holders in cement-they are all tore up and gone. They were fine for 20 years-why is it gone now. Are you going to replace it? After 20 years is gone-not right. Workers should be responsible.

Shauna Snyder-Grandparent's are at Oak Hill Cemetery. A friend grabbed the angel from their graves. I retrieved the veteran medallion. If you are not going to care for the cemetery and won't allow us, who is going to take care of it. I will care for my grandparent's graves. Items can never be replaced.

Mayor Lambert-In reviewing the cemetery issues from last year it became very clear that things needed to be handled differently this year. He will appoint 3 council members to form an Ad Hoc Committee to review the Cemetery By Laws and rules. The three council members are: Jeanie Brookhouser, Steve Riese and Morgan Muller.

Erv Portis, City Administrator-In response to not looking at people when they are speaking, he was writing what they were saying because it does matter and is important to him. Acknowledged that could have/should have done a better job communicating with the public. Goal is to be responsive to complaints. The Cemetery board has been inactive. Take the opportunity to review all aspects of the cemetery. Gave another apology to the public present.

ITEM 8 A

Council member Kerns stated that he would be abstaining from any discussion or action on this item as he has a conflict of interest.

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc. stated due to the flooding event in March 2019 and the impact on the water treatment facility, the City has been utilizing the existing Cass County Rural Water connection to supply their water system. Change Order No. 3 reflects an extension of the completion dates from April 1, 2019 for substantial completion to July 1, 2019, and a final completion date from April 15, 2019 to August 17, 2019 to allow for final seeding. Motion by Brookhouser seconded by Wiemer to approve Change Order No.3 submitted by Kerns Excavating Inc. for the Highway 75 Utility Relocations project for a contract time extension for a substantial completion date of July 01, 2019, and a final completion date of August 17, 2019 and authorize the Mayor to execute Change Order No.3. ROLL CALL: Yes-Riese, Wiemer, Minahan, Muller, Grimshaw, Brookhouser and Derby. No-None. Absent-None. Abstain-Kerns. MOTION CARRIED.

ITEM 8 B

Steve Perry PE, Olmsted & Perry Consulting Engineers Inc. informed the Mayor and Council that they were in the plant last Friday (April 12, 2019) with an electrician. They were pleasantly surprised on the condition, it could have been alot worse. Have been in contact with Nebraska Public Power District (NPPD) to get temporary power to the plant and Well #8. Well #8 can be operational with little work and it will provide water to clean the water treatment plant. This could happen as early as next week. The river level is a direct adversary-the only way to the water treatment plant is by boat. Will start with temporary power and water and will step right in to the recovery side. There is 36 – 37 inches of water over the road. Options for reaching the plant were discussed.

ITEM 9 A

Erv Portis, City Administrator gave a timeline and reviewed the rates the City would pay Cass County Rural Water District #1 for supplying water on an emergency basis. The water rates set by the Interlocal Agreement of 2011 does not reflect significant increase in the cost of supplying water and this amendment will adjust those rates: 3/14/2019 to 3/31/2019 the City will pay CCRWD1 \$2.16 per thousand gallons of water; 4/1/2019 and after the City will pay CCRWD1 \$2.40 per thousand gallons of water supplied to the City. The rate that is charged the users within the City will not change with this agreement. Motion by Muller seconded by Wiemer to approve the First Amendment To Interlocal Cooperation Act Agreement for Emergency Water Supply between the City of Plattsmouth and Cass County Rural Water District No. 1 which amends the Water Rate per thousand gallons set forth in Section 6.01 and authorize the Mayor to execute the Amendment to the Agreement. Pursuant to publication Mayor Lambert opened a public hearing at 8:34 p.m. to hear and consider public comment regarding a request by Wiles Brothers Inc. for a preliminary and final plat of a major subdivision to be known as Wiles Bros Subdivision, located north of Wiles Road and east of 6th Street, being a part of the Southeast One-Quarter of Section 23 and the Northeast One-Quarter of Section 26, all in Township 12 North, Range 13 East of the Sixth Principal Meridian, Cass County, Nebraska. Rich Parkinson, representing Wiles Brothers Inc. was available for questions. Kevin Larson, City Inspector and Zoning Administrator offered his memorandum dated April 11, 2019 to Mayor Paul Lambert and Plattsmouth City Council regarding Wiles Bros. Subdivision/Rezoning which he stated was in the packet for this meeting. No one else spoke in favor, opposition or of a neutral nature. Mayor Lambert closed the public hearing at 8:36 p.m.

Pursuant to publication Mayor Lambert opened a public hearing at 8:36 p.m. to hear and consider public comment regarding a request by Wiles Brothers Inc. for rezoning Lot 3 of the proposed Wiles Bros Subdivision from AG (Agricultural) and HI (Heavy Industrial) to HI (Heavy Industrial), and Lots 1, 2, 4 of the proposed Wiles Bros Subdivision from HI (Heavy Industrial) and AG (Agricultural) to AG (Agricultural). Rich Parkinson, representing Wiles Brothers Inc. was available for questions. Kevin Larson, City Inspector and Zoning Administrator offered his memorandum dated April 11, 2019 to Mayor Paul Lambert and Plattsmouth City Council regarding Wiles Bros. Subdivision/Rezoning which he stated was in the packet for this meeting. No one else spoke in favor, opposition or of a neutral nature. Mayor Lambert closed the public hearing at 8:38 p.m.

Erv Portis, City Administrator stated that approval of the plat would require approval of certain waivers of the subdivision ordinance as requested by the applicant, reflected in the Zoning Administrators memorandum, and recommended by the Planning Commission. Motion by Muller seconded by Riese to grant the waivers as requested by Wiles Brothers Inc. and approve a preliminary and final plat of a major subdivision to be known as Wiles Bros Subdivision, located north of Wiles Road and east of 6th Street, being a part of the Southeast One-Quarter of Section 23 and the Northeast One-Quarter of Section 26, all in Township 12 North, Range 13 East of the Sixth Principal Meridian, Cass County, Nebraska. ROLL CALL: Yes-Wiemer, Brookhouser, Riese, Derby, Muller, Grimshaw and Kerns. No-None. Absent-None. Abstain-Minahan. MOTION CARRIED.

SUBDIVISION, CASS COUNTY, NEBRASKA; TO CHANGE THE ZONING OF LOT 3 OF THE WILES BROS SUBDIVISION FROM THE HEAVY INDUSTRIAL (HI) DISTRICT AND THE AGRICULTURAL (AG) DISTRICT TO THE HEAVY INDUSTRIAL (HI) DISTRICT; TO CHANGE THE ZONING OF LOTS 1, 2, AND 4 OF THE WILES BROS SUBDIVISION FROM THE AGRICULTURAL DISTRICT (AG) AND THE HEAVY INDUSTRIAL (HI) DISTRICT TO THE AGRICULTURAL (AG) DISTRICT; TO AMEND THE ZONING DISTRICT BOUNDARIES AND OFFICIAL ZONING MAP OF THE CITY OF PLATTSMOUTH; TO REPEAL ALL ORDINANCES IN CONFLICT; TO PROVIDE FOR PUBLICATION IN PAMPHLET FORM; AND TO PROVIDE AN EFFECTIVE DATE as amended and distributed at the meeting.
