ITEM 7 C

Steve Perry, PE-Olmsted & Perry Consulting Engineers Inc., joining the meeting via ZOOM Meetings, reviewed two repair options for the extensive damage/severe erosion that was done at the Boat Ramp, Park and E. Main Street/Dock Road due to the Flood of March 2019. Option 1-provide access to the boat ramp, provide stone rip-rap to protect the boat launch area from high river water levels and provide a limited area for boat trailer staging and vehicle parking with a preliminary cost estimate of \$380,480.00; and Option 2-provide a gated access to the boat ramp for restricted use and provide stone rip-rap to protect the boat launch area from high river water levels with a preliminary cost estimate of \$216,050.00. Following further discussion on public access versus restricted access and the minimum cost to make the area accessible to the public, Mr. Perry was asked to prepare a cost estimate to make the area accessible to the public at a minimal cost. ITEM 7 D

Erv Portis, City Administrator reviewed the COVID-19 insurance requirements for youth baseball and softball organizations set forth in Resolution No. 20-007. It has been brought to our attention that the baseball/softball organizations cannot get the required coverage as the insurance industry is still defining what that coverage would be. Portis gave three options to consider: 1-hold firm on current requirements; 2-amend/relax COVID-19 coverage requirements; and 3-accept general liability coverage limits within policy. Steve Preston, City Attorney stated that the insurance requirement is one risk management strategy and there are other layers in place. After further discussion, an amendment changing the insurance requirement to be "ensure that such policies do not exclude coverage for claims related to COVID-19, novel coronavirus, and related issues", amend Exhibit E to the license agreement and number the amended resolution 20-007A. Motion by Brookhouser seconded by Muller to approve an amendment to RESOLUTION NO. 20-007, amending the insurance provision (ensure that such policies do not exclude coverage for claims related to COVID-19, novel coronavirus, and related issues) and Exhibit E to the License Agreement (numbering the amended resolution RESOLUTION NO. 20-
