Motion by Brookhouser seconded by Riese to approve Change Order No.5 submitted by West-E-Con Inc. for the 2019 Flood Recovery Project -Restore Secondary Electrical Service To the Wastewater Treatment Plant (PW#88688) for a contract time extension and authorize the Mayor to execute Change Order No.5. Steve Perry, PE-Olmsted & Perry Consulting Engineers Inc., joining the meeting via ZOOM Meetings, reviewed the Contractor's Application for Payment No.4 submitted by West-E-Con Inc. for the 2019 Flood Recovery Project Waste Water Treatment Plant Restore Secondary Electrical Service (PW#88688) in the amount of \$59,808.24. Mr. Perry stated Pay App No. 4 is a progress payment and reflects 95% complete and recommended approval. Motion by Riese seconded by Muller to approve Contractor's Application for Payment No.4 submitted by West-E-Con Inc.for the 2019 Flood Recovery Project Waste Water Treatment Plant Restore Secondary Electrical Service (PW#88688) in the amount of \$59,808.24 and authorize the Mayor to execute Pay Application No. 4. ITEM 7 C

Steve Perry, PE-Olmsted & Perry Consulting Engineers Inc., joining the meeting via ZOOM Meetings, reviewed the Bid Tab Sheet for the 2019 Flood Recovery Project – Sanitary Sewer CCTV Inspection (PW#88688) for a Unit Price Bid contract. Four bidders were contacted and two bids were received. After review of the bids Mr. Perry recommended award to Midwest Vac Professionals of Panora, Iowa at a bid amount of \$33,542.50 with the project to start immediately and be complete before the end of July 2020. Motion by Kerns seconded by Brookhouser to approve bid award and contract for the 2019 Flood Recovery Project – Sanitary Sewer CCTV Inspection (PW#88688) for a Unit Price Bid contract to Midwest Vac Professionals, Panora, Iowa at a contract price of \$33,542.50 and authorize the Mayor to execute the construction contract. ITEM 7 D

Council member Kerns stated that he would be abstaining from any discussion or action on this item as he is a potential bidder for this project. Steve Perry, PE-Olmsted & Perry Consulting Engineers Inc., joining the meeting via ZOOM Meetings, reviewed the Scope of Work for the Alternate Option which is to restore the function of just the boat ramp for public use and parking for 6 vehicles and trailers. The cost estimate on the Alternate Option is \$185,000.00. Nothing would be done to the picnic area, possibly relocating to another site in the future, and restoring the overhead power at the boat ramp is not included in this option. Future expansion of this area was also discussed, which this option does allow

for. Motion by Muller seconded by Clark to authorize the City Engineer to prepare bid specification documents based on the Alternate Option presented with the additional parking and solicit for bids and at review of bids the council will make a final decision on the Scope of Work for the project. ITEM 7 E

The following city facilities/public areas were discussed with regard to COVID-19:

PARKS: Placing signage (Directed Health Measures/guidelines) before opening the playground areas was discussed and there were no objections. THE PLAYGROUNDS WILL BE OPENED once signage is in place. The restrooms will not be opened and no reservations for the pavilions/gazebos-first come first served as long as the DHM/guidelines are not violated.

TWIN RIVERS WATER PARK: It was recommended that it NOT be opened due to the following reasons: 1) Staffing; 2) Attendance restrictions per DHM; 3) Projected loss to the General Fund. TWIN RIVERS WATER PARK WILL NOT OPEN FOR THE 2020 SEASON. Setting up the Splash Pad at the Entertainment Plaza was discussed. The SPLASH PAD WILL BE SET UP on Tuesday, Wednesday and Thursday at the Entertainment Plaza with the time to be determined. Elizabeth Glup, Recreation Director reviewed the indoor pool rules and restrictions.

LIBRARY: Karen Mier, Library Director reviewed the opening proposal. With no objections, the LIBRARY WILL OPEN AS PROPOSED ON WEDNESDAY, JUNE 17, 2020. The first 90 minutes (9:00 a.m. to 10:30 a.m.) of each day is reserved for seniors (age 55 and over).

CITY HALL: Erv Portis, City Administrator informed the Mayor and Council that Electronic Meetings will end June 30, 2020. Alternate locations for Council Meetings are being considered as the Council Chambers in City Hall will not accommodate the required 6 foot social distancing rule. CITY HALL WILL REMAIN CLOSED/APPOINTMENT ONLY THROUGH JUNE 30, 2020.

ITEM 7 F

Erv Portis, City Administrator reminded council that the original Option Agreement with the Plattsmouth Community School District was for a year (expired May 31, 2019) and it was extended twice, set to expire June 30, 2020. Portis said they have an Amendment (month-to-month option) or they could exercise their right to purchase at \$195,000.00 minus the \$30,000.00 already paid. Portis recommended exercising their right to purchase, under the Option Agreement, with Economic Development monies which would be paid back when the developer purchases the property. The development project has been slowed by the COVID-19 pandemic but are still meeting with the developer. Motion by Brookhouser seconded by Muller to exercise the option to purchase real property, more commonly known as the former Blue Devil Stadium, as per the Option Agreement between the Plattsmouth Community School District, a political subdivision of the State of Nebraska and the City of Plattsmouth, a Nebraska municipal corporation with Economic Development monies and authorize the Mayor to execute the documents. ROLL CALL: Yes-Derby, Muller, Wiemer, Kerns, Brookhouser, Riese, Minahan and Clark. No-None. Absent-None. Abstain-None. MOTION CARRIED
