Steve Perry PE, Olmsted & Perry Consulting Engineers, Inc. was present at the meeting. Mr. Perry stated he has met on more than one occasion regarding this situation. The options that were considered were reviewed. Mr. Perry recommended the placement of speed tables (humps) 100 ft. east and 100 ft. west from the crest of the hill on 2nd Avenue between 16th Street and 18th Street as a traffic calming solution. Council discussion: if speed tables are moved to close they defeat the purpose; sidewalks on the North side of 2nd Avenue as topography on the South side will not allow for placement of sidewalk; use of the speed trailer to monitor traffic/speed; speed table (humps) are concrete and will cause problems when plowing snow; and placement of possible signage. Motion by Kerns seconded by Clark to table the discussion regarding the use of speed tables (speed humps) as a traffic calming device, with installation of tables on 2nd Avenue between 16th Street and 18th Street as a demonstration project for effectiveness, pending further review and research. CON-CRET, LLC; Vireo Resources, LLC; and Vireo Systems, Inc. Vireo plans to create at least 35 jobs, 18 of which will be offered to or held by low and moderate income people. City of Plattsmouth will match up to \$192,762 of existing CDBG program income. There will be no displacement of any persons as a result of this project.
