ITEM 8 C

Emily Bausch, City Administrator, informed council that of the fifteen firms solicited for this project only two proposals were received. Of the two bids received Midwest ROW was the lower bidder and their familiarity with Plattsmouth and FEMA regulations make them an ideal choice for this project. 30% design on this project is not completed yet, but that should have little effect on right-of-way acquisitions. Following discussion, Motion by Brookhouser seconded by Forrest to accept a proposal for the right-of-way acquisition services for the 2019 Flood Recovery Project PW#88690 – Relocated Drinking Water Facility, and authorize the Mayor to finalize and execute, upon consultation with the City Attorney and City Administrator,

Emily Bausch, City Administrator, gave an update on the Harvest Festival insurance policy. The Harvest Festival has provided the City with an Insurance Certificate that meets the requirements that were asked for in coverage amounts and listing the City as additionally insured. The certificate states that all events were submitted to their carrier and exclusions are listed in the policy documentation, that was not provided to the city. The City Insurance agent has reviewed the insurance certificate and indicated it meets general liability policy standards. Following discussion, no action was taken.
