Mike Brodersen, 655 N 16th St, presented his case to have the alley vacated and absorbed by surrounding property owners. His family has been living at their residence for six generations and they would like to clean up the alley, that isn't maintained by the City, so the property can be landscaped for future generations of their family. Emily Bausch, City Administrator, referenced her Council memo stating this alley is not connected to any street and development of that area is

unlikely due to the railroad easement adjacent to the alley and properties. If Council approves vacating the alley City staff would draft an Ordinance to present to Council at a future meeting.
