Steve Rathman, Chief of Plattsmouth Police Dept., reviewed the Cellebrite software with Council and discussed its application in many forms of cyber and cellular crimes the department currently outsources. Outsourcing can be detrimental to investigations that require a quick response. This software will be a cost share with the Cass County Sheriff's Office and will also be an asset to the surrounding communities. Any future update fees will be budgeted or covered by grants. Following discussion, Motion by Muller seconded by Forrest to authorize the purchase of Cellebrite Inseyets Online Digital Forensics Software and Subscription for \$18,669.00 and

authorize the Mayor to execute all pertinent documents (Interlocal Agreement 50% cost share with Cass County Sheriff's Office and additional funding from an OUR Rescue grant).
