

Emily Bausch, City Administrator, and Damien Wright, City Attorney, reviewed State Statutes relating to bicycles, e-bikes, throttle bikes and other recreational motor assisted items that are increasing in usage on City streets. Damien expressed the need to properly define and categorize these items before looking at legislation. Emily stated most of these items are being used by unlicensed individuals that may not be aware of the risks these higher speed items pose on City streets.
