#### ITEM 4

MOTION BY RICE, SECONDED BY BARONI, TO APPROVE THE MINUTES OF THE May 16, 2013 MEETING. A voice vote in favor was unanimous, MOTION CARRIED.

Following discussion, MOTION BY BARONI, SECOND BY HALE, TO APPROVE A MINOR SUBDIVISION BY JENNIFER STANDER ON PROPERTY LOCATED AT 17975 18<sup>TH</sup> ST., PLATTSMOUTH, LEGALLY DESCRIBED AS TAX LOT 23, NE1/4,

NE1/4 SECTION 10, TOWNSHIP 12 NORTH, RANGE 13 EAST, CASS COUNTY, NEBRASKA.

On roll call, VOTING YES, RICE, PRINCE, HALE, KIEF, KINDIG, BARONI, MINAHAN. VOTING NO, NONE. ABSENT AND NOT VOTING, MCKINLEY, WEAVER, NICHOLS. MOTION CARRIED.

As the minor subdivision requires the zoning change, Larson said the minor subdivision would not be processed until the Plattsmouth City Council had taken action on the rezoning request.
