Nichols read from the agenda, "Consider a recommendation to the Plattsmouth City Council regarding corrections to The Land Development Ordinance for the City of Plattsmouth, August 2006, Table 4.5: R-2 Site Development Regulations." MOTION BY MINAHAN, SECONDED BY BOWMAN, TO RECOMMEND CHANGING TABLE 4.5: R-2 SITE DEVELOPMENT REGULATIONS OF THE LAND DEVELOPMENT ORDINANCE FOR THE CITY OF PLATTSMOUTH AUGUST 2006 TO STATE: MINIMUM LOT WIDTH (FEET) IN CONVENTIONAL DEVELOPMENT, 50'; MINIMUM YARD, (FEET) SIDE YARD, 5'; MINIMUM STREET SIDE YARD, 15'. On roll call, VOTING YES, BOWMAN, KIEF, HERLICK, KINDIG, NICHOLS, MINAHAN, RICE, PRINCE; VOTING NO, NONE; ABSENT AND NOT VOTING, MCKINLEY, WEAVER. MOTION CARRIED.

### ITEM 9

Nichols read from the agenda, "Discuss possible updates to the Land Development Ordinance for the City of Plattsmouth August 2006. Items discussed included fences, parks and common ground, size, height and sound levels of alternative energy sources, the restoration of property after demolition, parking lot landscaping, managing growth at the edge of the city, and water run-off.

In light of his resignation, effective June 1, 2015, Chairman Marc Nichols told the commission he has enjoyed working with everyone for the past 40 years, and that they should enjoy the successes that Plattsmouth has had and will have. "I will miss it."
