PLATTSMOUTH PLANNING COMMISSION MINUTES May 16, 2019

Meeting convened at 7:30 p.m. on May 16, 2019 at the Plattsmouth City Hall, 136 N. 5th Street, Plattsmouth, Nebraska. A copy of the agenda for the meeting is attached to these minutes. Kindig opened a public hearing at 7:32 p.m. and read from the agenda, "A public hearing regarding an application by the City of Plattsmouth for a Planned Unit Development District 1 (PUD1) described as:

Tract 1: Lots Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11) and fractional Lot Twelve (12), Block Eight (8), Original Town of Plattsmouth, Cass County, Nebraska.

Tract 2: Fractional Lots Seven (7) and Eight (8), Block Nine (9), lying Southwesterly of Washington Avenue, Original Town of Plattsmouth, Cass County, Nebraska.

Tract 3: All of Lot Six (6) and the North 60 feet of Lot Seven (7), Block Twenty-Two (22),
