Kindig read from the agenda, "A public hearing regarding a minor subdivision located east of Smith Avenue between 13<sup>th</sup> and 15<sup>th</sup> Avenues, legally described as Macedo 4<sup>th</sup> Subdivision, Lots 1, 2, 3 and 4, being a Replat of Lot 29, Wise's Outlets except the east 66 feet, city of Plattsmouth, Cass County, Nebraska, and opened the hearing at 7:34 p.m. Building and Zoning Administrator Kevin Larson entered his report and City Engineer Steve Perry's report into the record. Following discussion, "MOTION BY MCKINLEY, SECONDED BY PRINCE, TO APPROVE THE MINOR SUBDIVISION LOCATED EAST OF SMITH AVENUE BETWEEN 13<sup>TH</sup> AND 15<sup>TH</sup> AVENUES, LEGALLY DESCRIBED AS MACEDO 4<sup>TH</sup> SUBDIVISION, LOTS 1, 2, 3 AND 4, BEING A REPLAT OF LOT 29, WISE'S OUTLETS EXCEPT THE EAST 66 FEET, CITY OF PLATTSMOUTH, CASS COUNTY, NEBRASKA, WITH CONDITION THAT ENGINEER PERRY'S RECOMMENDATIONS THAT EASEMENTS FOR EACH LOT BE DEDICATED AS PART OF THE FINAL PLAT AND THAT THEIR BE NO EARTHWORK OPERATIONS WITHIN THE FLOOD ZONE ON LOT 4.
