PLATTSMOUTH PLANNING COMMISSION MINUTES November 18, 2021

Meeting convened at 7:30 p.m. on November 18, 2021 at the Plattsmouth City Hall, 136 N. 5th Street, Plattsmouth, Nebraska. A copy of the agenda for the meeting is attached to these minutes. Notice of the meeting, which communicated the availability of the agenda, was published in *The Plattsmouth Journal*, Plattsmouth, Nebraska, on November 4, 2021, with the Affidavit of Printer as proof of publication attached to these minutes. Notice of the meeting and the agenda were provided to all members in advance. All proceedings were taken while convened with attendance open to the public.

ITEM 1

Chair Mike Vaughn called the meeting to order at 7:30 p.m.

ITEM 2

Vaughn announced the location of the Open Meetings Act and of documents pertaining to the planning agenda.

ITEM 3

Answering roll call were Richard McKinley, Mike Bowman, Heather Herlick, Joe Woracek, Bill Boyle, Mike Vaughn, Dewayne Prince. Absent were Angela Minahan, Mary Harding.

ITEM 4

MOTION BY BOWMAN, SECONDED BY PRINCE, TO APPROVE THE MINUTES OF THE AUGUST 19, 2021 MEETING. On roll call: VOTING YES, BOWMAN, HERLICK, WORACEK, BOYLE, VAUGHN, PRINCE; VOTING NO, NONE; ABSTAIN, MCKINLEY; ABSENT AND NOT VOTING, HARDING, MINAHAN; MOTION CARRIED.

ITEM 5

Vaughn read from the agenda, "A public hearing regarding a rezoning request from Keeler Properties LLC from R3/PUD to R3 on property located at 2209 1st Avenue Plattsmouth, legally described as Plattsmouth Outlots Tax Lot 83 except Sub Lot 1 of 83 NW1/4, SW1/4, and Outlots 73 West of Railroad NE1/4 SW1/4 13-12-13." Vaughn opened a public hearing at 7:32 p.m. Brent Beller with the law firm of FJJB LLP spoke, stating the project proposed for the site would include 192 housing units to be built in three phases over two years, with construction beginning in spring 2022. No one else spoke, and Vaughn closed the hearing at 7:42 p.m.

Vaughn read from the agenda, "Consider a recommendation to the Plattsmouth City Council regarding a rezoning request from Keeler Properties LLC from R3/PUD to R3 on property located at 2209 1st Avenue Plattsmouth, legally described as Plattsmouth Outlots Tax Lot 83 except Sub Lot 1 of 83 NW1/4, SW1/4, and Outlots 73 West of Railroad NE1/4 SW1/4 13-12-13." City Inspector Kevin Larson spoke, stating the proposed project fit the site and did not require a Planned Unit Development (PUD) overlay. City Attorney Stephen Preston spoke, stating the proposed recommendation did not approve the preliminary site plan, only removed the existing PUD overlay. Following discussion,
