Vaughn opened a public hearing at 7:35 p.m. City Administrator Emily Bausch spoke about her memo to the commission and a corrected redevelopment plan. She said the redevelopment plan conforms to the city's comprehensive plan and of the need for multi-family housing in Plattsmouth. Brett Beller of the law firm FJJB LLP spoke about the phasing of the project and the extensive grading needed at the site. Developer Jesse Calabretto said his company has built the same project in Gretna, that there is a need for multi-family housing in the community, and the apartments will be market rate, with a one-bedroom unit renting for approximately \$700 a

month and a two-bedroom unit renting for between \$1,000 and \$1,200 a month. No one else spoke, and Vaughn closed the hearing at 7:46 p.m.
